**Conditions for exhibiting:** The participation fee is  $\notin 2.50$  per cage plus obligatory catalogue at  $\notin 5.00$  this has to be paid upon registration

Rings: Permitted are birds with the exhibitors own rings, which must be closed and fully intact.

In addition, colored rings are not allowed. These will be regarded as unauthorized identification and will lead to disqualification of the bird.

No liability for loss or damage during the transport or time of exhibition will be taken by the AZ.

# **ATTENTION!** Manipulation of the marking of rings/birds

Is a ring manipulation discovered all the exhibitors' birds will be banned in the first instance indefinitely to all AZ shows.

Is a manipulation of a bird discovered, all the exhibitors birds will be banned/disqualified and barred until the 31.12 of the following year.

Manipulation of the bird or ring by non-members will lead to a ban of all the exhibitors' birds.

The department of veterinarians demands that the breeder's number on the registration form corresponds with the breeder's number on the birds ring.

This is particularly essential were members belonging to several clubs/organizations.

If the numbers given on the registration form do not correspond with the breeder's number on the ring, the breeder will be disqualified.

## To be exhibited

Budgerigars- single birds, pairs and collections, each divided into old/young and

Breeding steps CH as well as Z and F with single birds additionally to cock and hen.

Food (ca 3 cm) must be provided on the floor of the cage. The drinking bowl is to be attached at the top of the cage. Permitted are only drinking bowls with wide white snack bowls. Under no circumstances should water bottles or drinking tubes be used. Should any of these be used by exhibitors on exhibition days, these Will be removed by show officials with no compensation.

According to the resolution of the AZ DWV gremium meeting of the 30th march 2010 and that of the DWV meeting at the AZ Bundesshow 2009, the exhibition stages F and Z are being combined.

## **Registration and Catalogue/Stand payment.**

It is strongly recommended to pre-register all birds, however this will only be dealt with once required payment has been received by the required date...

**Bird stock market:** In conjunction with the show, a bird stock market will take place for budgerigars. The same conditions apply as with the AZ-Bundesshow. A pre-registration of the birds for sale is not necessary.
